Storage conditions:

The product should be stored on pallets in a dark, clean, dry and well-ventilated storage facility. The facility should be free from foreign smell, free of pests and their residues and away from the wall, at least 0,5m away from heaters, sewers and water supply pipes. Aldebaran advises storage temperature: 8-14 °C. Relative humidity should not exceed 75%. Store at a temperature not exceeding 20°C.
